



TCR² Therapeutics Reports Inducement Grants Under Nasdaq Listing Rule 5635(c)(4)

CAMBRIDGE, Mass., May 02, 2022 (GLOBE NEWSWIRE) -- TCR² Therapeutics Inc. (Nasdaq: TCRR), a clinical-stage cell therapy company with a pipeline of novel T cell therapies for patients suffering from solid tumors, today announced that on April 29, 2022 (the "Grant Date"), the Compensation Committee of the Board of Directors of TCR²s approved the grant of inducement stock options covering an aggregate of 57,200 shares of TCR²s common stock to 4 new non-executive employees. The stock options were granted as an inducement material to the employees' acceptance of employment with TCR² in accordance with Nasdaq Listing Rule 5635(c)(4).

The stock options have an exercise price per share equal to \$2.13, which represents the closing market price on the Nasdaq Stock Market of TCR²s common stock on the Grant Date. The stock options have a ten-year term and will vest over a four-year period, with 25% of the options vesting on the first anniversary of the employees' date of hire, and the remaining 75% of the options vesting in equal monthly installments for three years thereafter, subject to the employees' continued employment with TCR² on such vesting dates. The options are subject to the terms and conditions of TCR²s 2022 Inducement Plan and the stock option agreement covering the grant.

TCR² Therapeutics Inc. is a clinical-stage cell therapy company developing a pipeline of novel T cell therapies for patients suffering from solid tumors. The company is focused on the discovery and development of product candidates against novel and complex targets utilizing its proprietary T cell receptor (TCR) Fusion Construct T cells (TRuC[®]-T cells). The TRuC platform is designed to specifically recognize and kill cancer cells by harnessing signaling from the entire TCR, independent of human leukocyte antigens (HLA).
